

**THE STRAND MELBOURNE TERMS AND CONDITIONS FOR
“WIN A NIESSING NOW TATTOO BRACELET THIS CHRISTMAS” 2018
PROMOTION**

1. Information on how to enter and prizes form part of these Terms and Conditions. Participation in this **“WIN A NIESSING NOW TATTOO BRACELET THIS CHRISTMAS”** Promotion (**“Promotion”**) is deemed acceptance of these Terms and Conditions. All times stipulated in these Terms and Conditions are based on VIC local time.

ELIGIBILITY

2. Subject to condition 3, this Promotion is only open to Victorian residents aged 18 years or over.
3. The following are ineligible: (i) employees of the Promoter, ISPT PTY Ltd, JLL or any of the tenants or retailers in The Strand Melbourne (**“Participating Centre”**) or any of the Promoter’s agencies that are associated with the Promotion; (ii) the spouse, defacto spouse, parent, child or sibling (whether natural or by adoption) of an excluded employee; and (iii) any person who the Promoter has previously notified is not permitted to enter the Promoter’s promotions.
